The **Pitt County Construction & Demolition** (C&D) Debris Recycling Facility officially opened on April 5, 2017.

The project cost approximately \$2M, and followed the U.S. Green Building Council's (USGBC) Leadership in Energy and **Environmental Design** (LEED) standards.





<u>Transfer Station Tipping</u> <u>Fees</u>

Residential Waste = **No Charge**

Commercial or Non-Residential Waste = **\$45 per ton**

Construction and Demolition Debris = **\$40 per ton**

Household Fee = **\$71 per**


